Alaska's Economy Since Statehood: The ISER MAP Economic Data Base

INTRODUCTION

This *Review* presents the most comprehensive collection of economic data presently available on Alaska's economy. It provides a record of economic activity from the time of statehood, with data from a variety of federal and state sources, as well as information generated by the University of Alaska's Institute of Social and Economic Research (ISER).

We believe this data will be useful for:

- Improving our readers' general understanding of Alaska's economy and how it has grown.
- Monitoring economic trends and performance in relation to past levels of activity.
- Providing an analytical base and framework for understanding future directions of growth and development of the economy.

The data presented here in tabular form has been selected from our computerized body of information or "data base" on the Alaska economy which we have for several years collected and maintained in conjunction with our Man-in-the-Arctic economic modeling program (MAP). Although we originally created this data base for our own internal use—for developing econometric models of the state—it has since proved valuable to not only professional analysts but the public as well. As a result, and in keeping with ISER's goal of generating useful information on Alaska's economy and disseminating it to all interested Alaskans, we decided to publish portions of the data base. The kinds of information included here are those most often requested. Addi-

tional information on the MAP data base as well as on other data sources maintained by ISER, such as the U.S. Census, is available on request.

THE ALASKA ECONOMY SINCE STATEHOOD

Alaska's economy since statehood can be divided into two important periods, separated by the beginning of construction on the Trans-Alaska Oil Pipeline System (TAPS) in 1974.

1961-1973, Statehood Implementation

Implementation of statehood and its effects dominated the Alaska economy in the decade of the 1960s. Growth was strong in all sectors except federal government. The dimensions of this growth can be broadly described as follows:

- Production of goods and services grew almost 5 percent a year, a rate substantially higher than the U.S. average.
- Employment expanded to meet the greatly increased demands for labor, with a substantial share of new jobs being filled by workers moving to Alaska from other states.
- Population, through both natural increase and net migration, grew at 3 percent a year, more than double the national average.
- Disposable personal income in Alaska, as well as average earnings per employee, grew both absolutely and relative to the U.S. average. And with consumer prices rising slower in Alaska, real disposable personal income (after inflation) grew at 7 percent a year, a rate 50 percent above the U.S. average.

Alaska's Economy Since Statehood

Scott Goldsmith is an associate professor of economics and Teresa Hull and Brian Reeder are research associates; all are with the Institute of Social and Economic Research in Anchorage.

Growth in state and local government as well as in the support and infrastructure* sectors of the private economy accounted for most of the employment increase between 1961 and 1973. This growth reflected in large part Alaskans' desire to build the infrastructure and provide the public services necessary to support the economy of their new state. The public sector growth contributed directly to infrastructure growth and stimulated growth in the support sectors as well. Despite rapid growth in these sectors, the federal government still directly accounted for more than one in four Alaska jobs in 1973.

Total employment in basic sector industries grew very little, but a decline in federal government employment was offset by growth in mining (including petroleum), manufacturing, and tourism. However, during this time certain major events in the private economy foreshadowed things to come. These included the development of the Cook Inlet petroleum discoveries, the 1968 discovery of oil at Prudhoe Bay on the North Slope, and the passage of the Alaska Native Claims Settlement Act (ANCSA) in 1971.

*Economic infrastructure is the underlying foundation upon which an economy is built. It includes the basic supporting services required by an economy to operate, such as communications, transportation, and public utilities.

1974 to Present—The Petroleum Economy

The beginning of TAPS construction marked for the Alaska economy a new period of rapid growth dominated by petroleum. Growth in other basic industries also contributed to expansion of the basic sector. Development of an economic infrastructure and expansion of public service delivery systems continued to drive the growth of state and local government, and support industries continued to expand in response to these developments. At the same time, federal government continued its decline begun in the late 1950s. The dimensions of growth between 1973 and 1982 were as follows:

- Production of goods and services grew at nearly 11 percent a year.
- Employment grew by 94,000—a nearly 6 percent annual increase—and provided more than enough jobs for the expanding labor force.
- Population growth, mainly through net immigration, increased the population by 3.6 percent a year.
- Real disposable personal income grew at more than 6 percent annually.

TAPS construction resulted in a 3-year boom which dominated the growth of the economy in the mid-1970s. Since 1973, continued exploration,

development, and production of petroleum, which has shown an 18 percent annual increase in employment, has represented the fastest-growing basic industry in the economy. Tourism and fish harvesting have been the other expanding basic industries.

Government revenues from petroleum production have provided the other impetus to growth in this period, first after the state received a \$900 million bonus in 1969 for North Slope lease sales on state lands, and more recently since the dramatic increase in world oil prices. State government spending fueled by petroleum revenues has been the primary cause of the economic boom (comparable to the TAPS boom), which the state has been experiencing since 1980.

Economic growth, driven by these factors, as well as by the establishment of the Alaska Native Corporations and related ANCSA activities, has been amplified by employment growth in the support and infrastructure sectors. The causes of such growth are as follows:

- Multiplier effects: the circulation in Alaska of personal and business income generated by direct state spending and the petroleum industry which provides additional employment in the retail and wholesale trade, finance, and service industries.
- Import substitution and support sector diversification: the expansion and improvement of the trade, finance, and service sectors through the provision of new, previously unavailable goods and services resulting over time in an ever larger "multiplier."
- Privately financed "catch-up" capital construction: construction of residences and commercial buildings, undertaken as a response to past growth in basic industry income.
- Anticipatory private capital construction: construction undertaken in the expectation of future growth in basic industry or state spending of oil revenues.

GUIDE TO USING THE ISER-MAP DATA BASE

The information on Alaska's economy presented in the following pages includes (1) "raw data" taken directly from various government sources which collect it and (2) data derived by ISER researchers through manipulation of the raw data. Each data entry includes in parentheses an encoded name which identifies it in the computer. A document en-

titled "ISER MAP Economic Database-Data Sources and Derivations," which describes the source or derivation of each data series, is available upon request at ISER.

Monetary figures are sometimes given in current dollars and sometimes in constant or "real" dollars—dollars adjusted for inflation to a base year, such as 1967. Since inflation gradually reduces the value of a dollar from one year to the next, real changes in dollar amounts net of inflation often provide a better picture of trends in the economy.

Because this material was developed for use in a computer model of the economy, it contains some terms which may not be familiar to the general reader. These are defined below:

Endogenous (produced from within): variables whose values are determined by MAP model computations.

Exogenous (produced from without): variables whose values are determined outside the economic model and used as inputs to the model.

Basic Industries produce exportable commodities that drive the economy. These include agriculture, forestry, mining, and petroleum manufacturing for foreign and lower forty-eight markets, fishing, tourism, and portions of construction and transportation. We also include federal civilian and military activities as basic industry, for although they do not produce goods as such, they do produce services for all Americans.

Support Industries produce goods and services to support basic industries or Alaska residents. These include retail and wholesale trade, real estate, finance, insurance, and most services.

Infrastructure Industries comprise the public utility, transportation, communication, business, and other systems needed by basic and support industries to function properly.

Enclave Activity: a self-contained project, such as the Trans-Alaska Pipeline System (TAPS), which has little interaction with the immediate surrounding or local economies, but may influence the state economy. TAPS has been Alaska's most significant construction project since statehood; it greatly influenced the state's economy in the mid-1970s. Because it was a unique event, it is sometimes helpful to isolate TAPS and look at the rest of the economy without it.
